The State's Attorney of said County charges:


That on April 26 , 2024, in Champaign County, Victor H. Smith committed the offense of

OBSTRUCTING A PEACE OFFICER
CLASS A MISDEMEANOR

720 ILCS 5/31-1(a-5): Mandatory minimum 48 consecutive hours imprisonment
or 100 hours of public service work

in that the said defendant knowingly obstructed the performance by University of Illinois Police Officer Lt. Jason Bradley and other officers of an authorized act within their official capacity, namely assisting in the clearing of unauthorized structures from University property adjacent to the Alma Mater, knowing Lt. Bradley and the other officers present to be peace officers engaged in the execution of their official duties, in that the defendant linked arms with others to form a barrier in order to block the officers from allowing UIUC Facilities and Building Services workers safe access to the structures,

in violation of 720 ILCS 5/31-1(a)(2).
